A MESSAGE FROM THE EXECUTIVE DIRECTOR

Dear friends,

I have been thinking a lot over the past year about how difficult it is to bring about real and lasting change. The hardest part is evaluating whether any change is worth the risks—or if it could make things worse. But to make real and lasting change—especially when it comes to homeless services—we have to take risks and think big.

On August 1, 2017, over two dozen community partners agreed to think big about the needs of homeless youth and young adults (16-24 years old). We vowed we would house 100 young adults in 100 days. This bold goal represented a 500% increase in the rate at which we have been housing young people in Louisville.

The team started by looking at process improvements, but that wasn't working quickly enough to meet the goal in time. So we adopted a new approach: fail fast and fail cheap. We tried lots of new ideas quickly, rather than wasting time debating the pros and cons of various solutions or falling too hard for one idea.

I'm thrilled to report that we had many wins as a result of this approach. Local police rescued several victims of sex trafficking, homeless youth received special vouchers to help them with mental health needs for the first time, and Jefferson County Public Schools began identifying vulnerable students sleeping in cars who needed to get to a place of stability.

Thanks to the hard work of our team, we successfully housed 112 young adults over those 100 days—and we learned so much in the process.

Of course, our work is not done. There are still over 130 known homeless youth and young adults living on the streets of Louisville, and we aim to end homelessness for all youth and young adults by 2020. And while we have learned how to provide housing more quickly, emergency shelter options continue to decrease—making it more difficult to keep these young people safe and off the streets while they seek housing.

So I invite each of you to join us.

After you've read this report, turn to the last page, "Where We Go From Here." Find a way to get involved that works for you.

Everyone can do something to improve the life of a homeless person, and it will take all of us to solve the problem of homelessness.

It takes a village, and I am happy my village is Louisville.



WE'RE ON A MISSION


The mission of the Coalition for the Homeless is to prevent and end homelessness in Louisville through advocacy, education, and the coordination of our 30+ member agencies and dozens of other community partners. We have been the lead advocate for the homeless since 1986, when we were founded after several people died on Louisville's streets.

Our programs address the root causes of homelessness and make services more cost-effective, efficient, and compassionate.

Our member agencies provide housing, food, clothing, healthcare, counseling, and legal services to the homeless — from veterans living on the streets to families living out of their cars.

Our job is to evaluate the needs of the homeless and of our agencies, to identify and address gaps in service community-wide, and to implement smart, long-term solutions.

We know that no single person or organization can solve the complex problem of homelessness. But we do believe that, *together*, through intensive collaboration and relentless focus on our ultimate goal, we *can* end homelessness in Louisville.

2017 HOMELESS SYSTEM OUTCOMES

Homelessness has many causes. The primary one is poverty. While the Coalition and our partners are becoming more efficient and more effective every day, there is a great deal that is out of our control, especially federal resources available for permanent, supportive, and affordable housing.

Together, we have made significant strides in ending homelessness among veterans, the chronically homeless, and young adults. However, we need your continued support, engagement, and advocacy in order to continue to effect meaningful change for our most vulnerable neighbors.

This is one of the Coalition's core values. Accordingly, these outcomes are a result of real collaboration as we all focus on ending homelessness for as many Louisvillians as possible. We are proud to stand alongside our partners behind these results.

- At Stand Down, more than 200 volunteers helped 408 homeless individuals access resources from 65 different organizations, ranging from healthcare and baby supplies to footwashing and housing resources.
- 300 compassionate Louisvillians volunteered for our **2018 Street Count** in January. These volunteers counted and gathered information on the most vulnerable Louisvillians who are sleeping outdoors during the coldest time of the year.
- Together with Councilman Bill Hollander, the Coalition worked to draft an **ordinance that provides basic protections to residents of homeless camps**, then asked Louisvillians to reach out to their council members about this critical ordinance. As a result, it passed overwhelmingly with bipartisan support.
- We launched the Host Homes Pilot Project to End Youth Homelessness, thanks to
 the generous investment of several local foundations. This program, which is being
 carried out by Home of the Innocents, invites local families to provide temporary,
 compassionate housing to homeless young adults while they transition to permanent

- We **trained more than 165 case managers** in trauma-informed care, convened a training on fair housing issues for senior staff of homeless service agencies, and trained our partners in better client data management.
- We called on the community to support Metro Government funding for the Louisville
 Affordable Housing Trust Fund—and the community showed up! \$9.57 million was
 allocated, and that money has already been put to work increasing the affordable
 housing stock in Louisville.
- Our stellar **Associate Board** continued their good work, hosting the inaugural **Craft Beer Throwdown**, which raised \$13,500 for ending youth homelessness!
- Musicians, chefs, sound techs, community volunteers, and donors came together to make the 7th Annual Give-a-Jam to End Homelessness a huge success! We raised more than \$50,000 to end homelessness.
- We supported quarterly Good News Parties, bringing together volunteer homeless outreach groups to help them better coordinate their extraordinary efforts.




