A MESSAGE FROM THE EXECUTIVE DIRECTOR

Dear friends,

The Coalition for the Homeless had two extraordinary successes in 2018, thanks to the coordinated efforts of dozens of community partners.

First, thanks to the generosity and vision of early funders, we created a new **Family Homelessness Prevention & Diversion Program** at the Coalition. In their first year, Erin and Tonia worked tirelessly to meet the needs of the 70+ families on our nightly waiting list for emergency shelter.

They prevented 34 families from becoming homeless and diverted 150 more from ever having to enter a shelter. They served 488 people – and their first year does not end until June! Now, our staff and Board are committed to expanding the program to other populations and strengthening our commitment to the belief that the best homeless services focus on prevention.

Second, Louisville has become a nationwide model in our efforts to address youth and young adult homelessness. Because of the work of over 70 partners, we received a competitive U.S. Department of Housing and Urban Development grant for \$3.4 million that is renewable for years to come.

With this resource, and with your continued support, we plan to reach "functional zero" for youth and young adult homelessness by the end of 2020. Furthermore, we will help other communities hoping to achieve the same by sharing our best practice

models, such as Family Scholar House and Host Homes.

However, we still have much work to do. We are all deeply concerned about the neighbors who are sleeping on our streets, a problem that has become more and more visible in recent years. With the provision of over \$500,000 from the City, Louisville has tested models for addressing this crisis. We've learned that those in need will come in if adequate shelter is available. A study is underway at the University of Louisville that will provide evidence-based, long-term recommendations for how we can best address our city's street homelessness crisis. We must all be united in using this data and in holding our leaders accountable. We cannot ignore the need.

Metro Council and other community leaders must hear a **strong and united voice** if we are to receive the funds needed and implement the best practices that have already been tested in our community. The fight won't be easy. But I do believe that, together, we can continue making Louisville a better city for all of us.



WE'RE ON A MISSION

The mission of the Coalition for the Homeless is to prevent and end homelessness in Louisville through advocacy, education, and the coordination of our 30+ member agencies and dozens of other community partners. We have been the lead advocate for the homeless since 1986, when we were founded through a County task force after several people died on Louisville's streets.

Our programs address the root causes of homelessness and make services more cost-effective, efficient, and compassionate.

Our member agencies provide housing, food, clothing, healthcare, counseling, and legal services to the homeless — from veterans living on the streets to families living out of their cars.

Our job is to evaluate the needs of the homeless and of our agencies, to identify and address gaps in service community-wide, and to implement smart, long-term solutions.

We know that no single person or organization can solve the complex problem of homelessness. But we do believe that, *together*, through intensive collaboration and relentless focus on our ultimate goal, we *can* end homelessness in Louisville.

2018 HOMELESS SYSTEM OUTCOMES

Homelessness has many causes. The primary one is poverty. While the Coalition and our partners are becoming more efficient and more effective every day, there is a great deal that is out of our control, especially federal resources available for permanent, supportive, and affordable housing.

Together, we have made significant strides in ending homelessness among veterans, the chronically homeless, and young adults. However, we need your continued support, engagement, and advocacy in order to continue to effect meaningful change for our most vulnerable neighbors.

- 1. 4.3% more individuals engaged with the homeless system at least once throughout 2018 than throughout 2017.
- 2. Each year, the Coalition coordinates, writes, and submits the grant application to the Department of Housing and Urban Development on behalf of all Louisville homeless services.
- 3. "Functional Zero" means that, on average, we house more veterans per month than the number who become homeless.
- 4. During extreme weather, three emergency shelters open their doors in excess of their normal capacity to ensure people have a safe place to stay out of the elements.

This is one of our core values. We know that real progress can happen only when we roll up our sleeves and work together toward a common goal. We're proud to stand beside our partners behind these results.

- We were selected as one of 11 U.S. communities to receive a **HUD Youth Homelessness Demonstration Program grant**, bringing \$3.45 million to Louisville to end young adult homelessness.
- We launched a new **Family Homelessness Prevention & Diversion Project**. In its first 8 months, we diverted 150 homeless families from entering emergency shelter and prevented 34 families from becoming homeless in the first place. In total, we helped 488 people increase self-sufficiency and stability.
- We supported the **launch of a new women-only day shelter, UP for Women & Children.** In its first 100 shifts of operation, UP served 335 women through 2,780 visits and directly helped 68 women and children transition into permanent housing.
- 350 compassionate Louisvillians volunteered for our **2019 Street Count**, which fell during the polar vortex in late January. They counted and gathered information on the most vulnerable Louisvillians those who were sleeping outdoors during the coldest time of the year.
- We worked alongside Metro Council, the Office of Resilience & Community Services, and the Homeless Encampment Task Force to create **comprehensive plans to meet the short-term and long-term needs of people sleeping on the street**.
- We trained more than 135 case managers in trauma-informed care, legal issues, LGBT equity & fair housing, and intimate partner violence.
- Our stellar **Associate Board** of young professionals grew stronger and continued their good work. They hosted the 2nd annual **Craft Beer Throwdown**, raising \$14,500!


