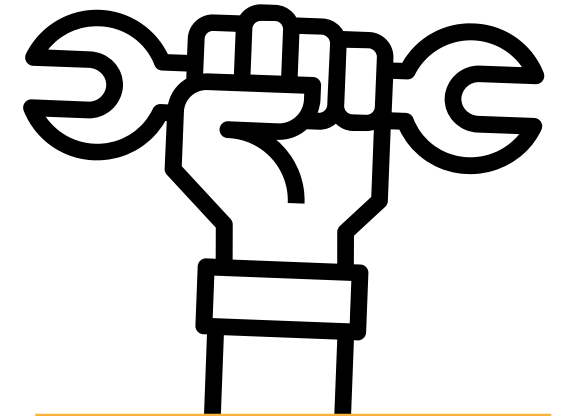
Legal Aid Society waxay bixisaa adeegyada sharci bilaash kuwa u qalma.

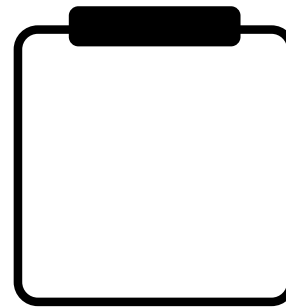
Doorashada #2 - Dayactirka & Ka-goynta
